Introduction

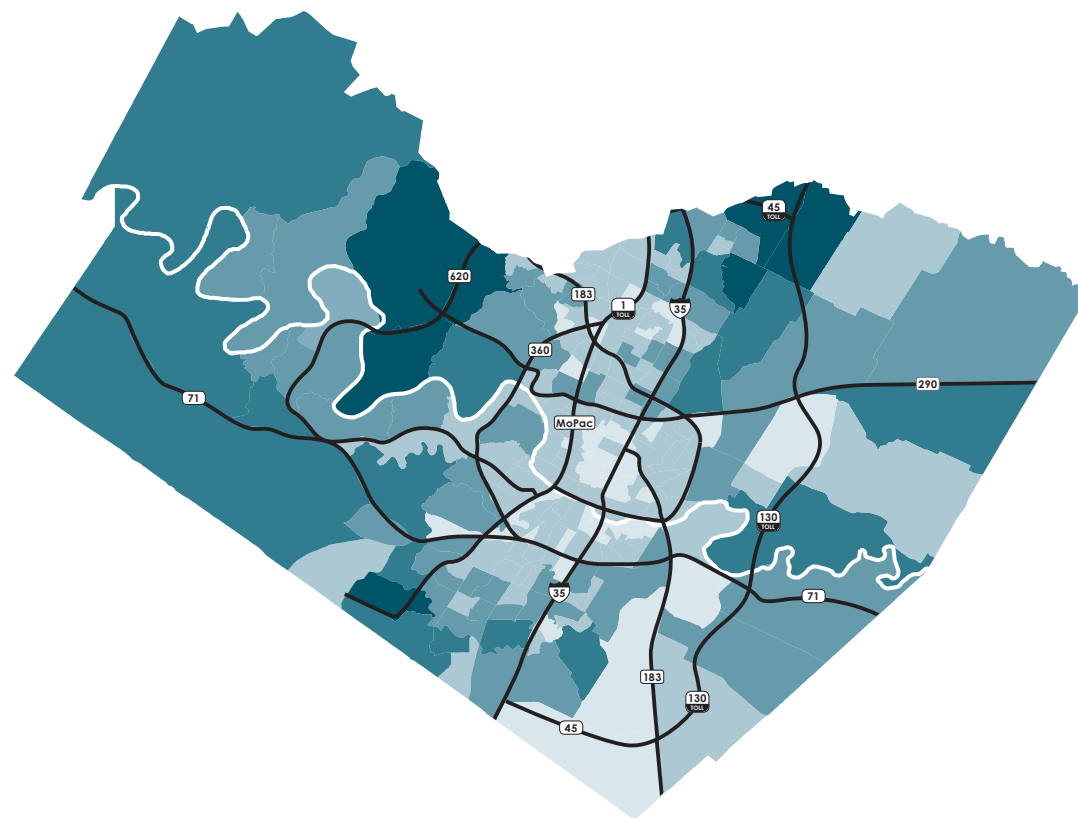

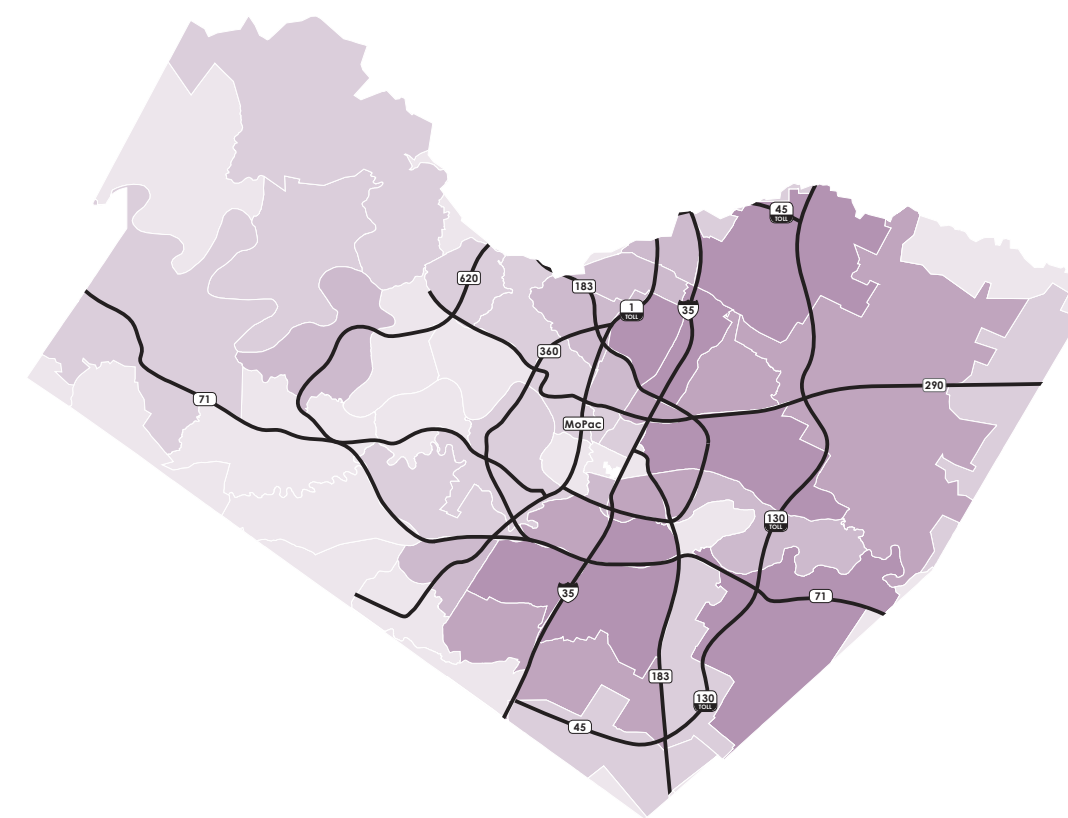


Census Tracts

Whenever possible, this report utilizes census tracts to identify population and demographic trends in Travis County. Census tracts are geographic boundaries identified by the U.S. Census Bureau whose primary purpose is to provide stable geographic units for the presentation of statistical data. According to the Census Bureau:

- Census tracts generally have a population between 1,200 and 8,000 people, with an optimum size of 4,000 people.
- A census tract usually covers a contiguous area; however, the spatial size of census tracts varies widely depending on the density of settlement.
- Census tract boundaries are delineated with the intention of being maintained over a long time so that statistical comparisons can be made from census to census.
- Census tracts occasionally are split due to population growth or merged as a result of substantial population decline.

There are 217 unique census tracts in Travis County, with populations ranging from 22,578 (East Pflugerville) to 369 (Northeast Tarrytown).



Zip Codes

This report utilizes ZIP codes to identify geographic boundaries where census tract-level data is not available. ZIP codes were developed by the U.S. Postal Service in the 1960s to identify service delivery points. ZIP codes are not required to follow geopolitical boundaries such as city, county or state lines. However, ZIP codes do provide geographic reference points to people familiar with Austin and Travis County.

Poverty thresholds vs. poverty guidelines

The federal government utilizes two standards to determine poverty status for U.S. residents: poverty thresholds and poverty guidelines. According to the U.S. Department of Health & Human Services (HHS):

The poverty thresholds are the original standard for measuring poverty. They are updated each year by the Census Bureau. The thresholds are used mainly for statistical purposes — for instance, preparing estimates of the number of Americans in poverty each year.

This report utilizes poverty threshold data collected by the Census Bureau for tracking and projecting families in poverty. For context, an individual living at the maximum poverty threshold would earn \$12,228 per year, equating to \$1,019 per month, \$235 per year, and an hourly wage of \$5.88. For a family of four with two wage earners the threshold would equal \$24,563 per year, \$2,047 per month, \$472 per week, and an hourly wage of \$5.90 per earner.

Poverty guidelines are the other federal poverty measure, and are often referred to as the “federal poverty level” or FPL. They are issued each year in the Federal Register by HHS. The guidelines are a simplification of the poverty thresholds and are used for administrative purposes — for instance, determining financial eligibility for subsidy assistance programs.

FPL guidelines are used to determine eligibility for Central Health, state-funded health care programs and Affordable Care Act Marketplace subsidies.

Families

This report measures and provides statistical comparisons of changes in total families and changes in families in poverty. A unique family may count as two or more related people living together. To calculate total family income, every related family member’s annual income is added together. If the family’s total income is below the poverty threshold, then the family and every individual in it is considered in poverty.

In Travis County in 2017 there are an estimated:

- 275,722 families
- 33,061 families in poverty
- 12 percent of families living in poverty

Patients

In this report patients are defined as individuals receiving health care funded through:

- The Central Health Medical Access Program (MAP) administered by the Community Care Collaborative (CCC);
- Local sliding fee scale subsidy programs reimbursed by the CCC;
- CommUnityCare patients regardless of payer source (Medicaid, Medicare, insurance, etc.);
- Uncompensated care at local hospitals supported by Central Health.

MAP provides a defined benefit package to eligible residents who are at or below 100 percent of the FPL. Residents earning up to 200 percent of the FPL may receive subsidized health care on a sliding fee scale through Central Health and the CCC’s network of primary care providers. CommUnityCare is an affiliated but separate 501(c)(3) organization of Central Health that provides medical, dental, behavioral health and prescription services and is Travis County’s largest Federally Qualified Health Center (FQHC) system.

In fiscal year 2016:

- The CCC provided hospital and outpatient care for 87,910 unique patients,
- CommUnityCare provided outpatient clinic-based care for 91,031 unique patients.
- Central Health funded care for more than 143,000 unduplicated patients.

Gentrification

For the purposes of this report, the term gentrification refers to the process of renewing and rebuilding urban areas accompanied by the influx of middle-class or affluent residents. This process often displaces lower-income residents. The term is not defined by race or ethnicity.

Data Sources

For current and future projections of populations, population demographics, families, families in poverty and households without vehicles, this report uses Nielsen’s Pop-Facts Premier database for 2017. This database incorporates the Census Bureau’s American Community Survey and other market data sources to provide current year and projected data at the level of Census geographies. This report also uses publicly available Census, city of Austin and Travis County geography files.

Patient-level data was compiled by the Community Care Collaborative and CommUnityCare analytics teams. Overlapping patient data was de-duplicated by the Central Health Joint Technology Team.

Public transportation routes were provided by the Capital Metropolitan Transportation Authority.

The City of Austin Neighborhood Housing and Community Development Office provided affordable housing data and mapping locations.

CENTRAL HEALTH PROVIDER NETWORK

Central Health is not a direct provider of health care services. Instead, the healthcare district works with a network of primary care, specialty care, hospital and other providers to deliver health care to Travis County's low-income and uninsured populations. The majority of these contracts are funded through the Community Care Collaborative, the non-profit partnership formed by Central Health and Seton Healthcare Family to better manage the care of their shared patient population. These public/private partnerships allow Central Health to maximize the use of its funding, and support patient care in a robust variety of settings.

The providers listed on Page 5 and Page 6 are effective as of Oct. 1, 2017; the list is subject to change as new service locations are determined.

Urgent/ Convenient Care Locations

Primary Care Locations

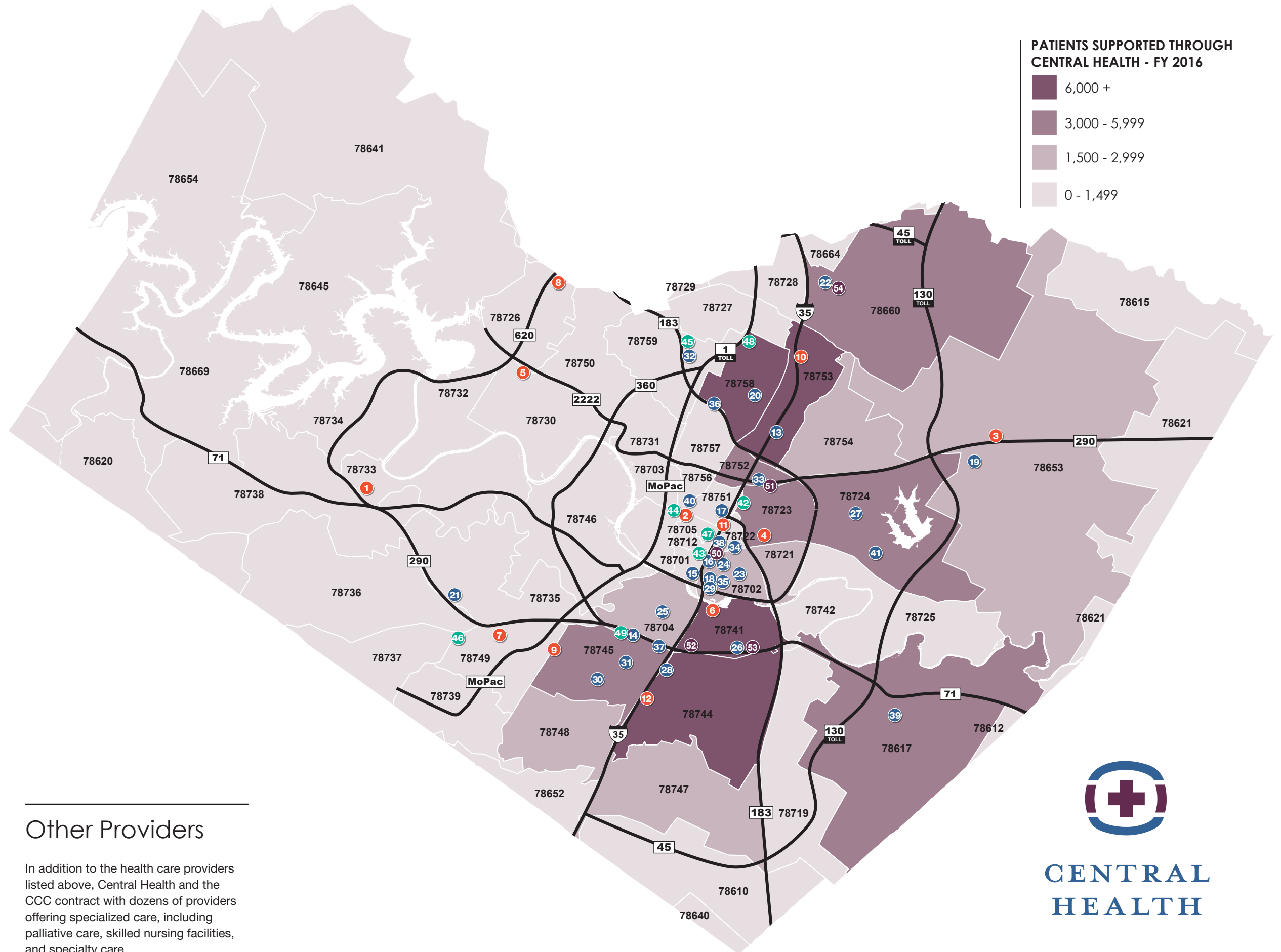

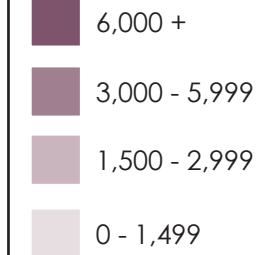

TRAVIS COUNTY FAMILIES—2017

There are an estimated 275,722 families residing in Travis County in 2017.

The greatest concentrations of families reside in Pflugerville, Northwest Austin and the Circle C area. These three areas encompass seven census tracts populated by 32,956 families—12 percent of the county's total families.

In Travis County, population density does not always equate to high concentrations of poverty. In Travis County's seven most densely populated census tracts, 4 percent of all families are living in poverty, compared to the county's overall rate of 12 percent.

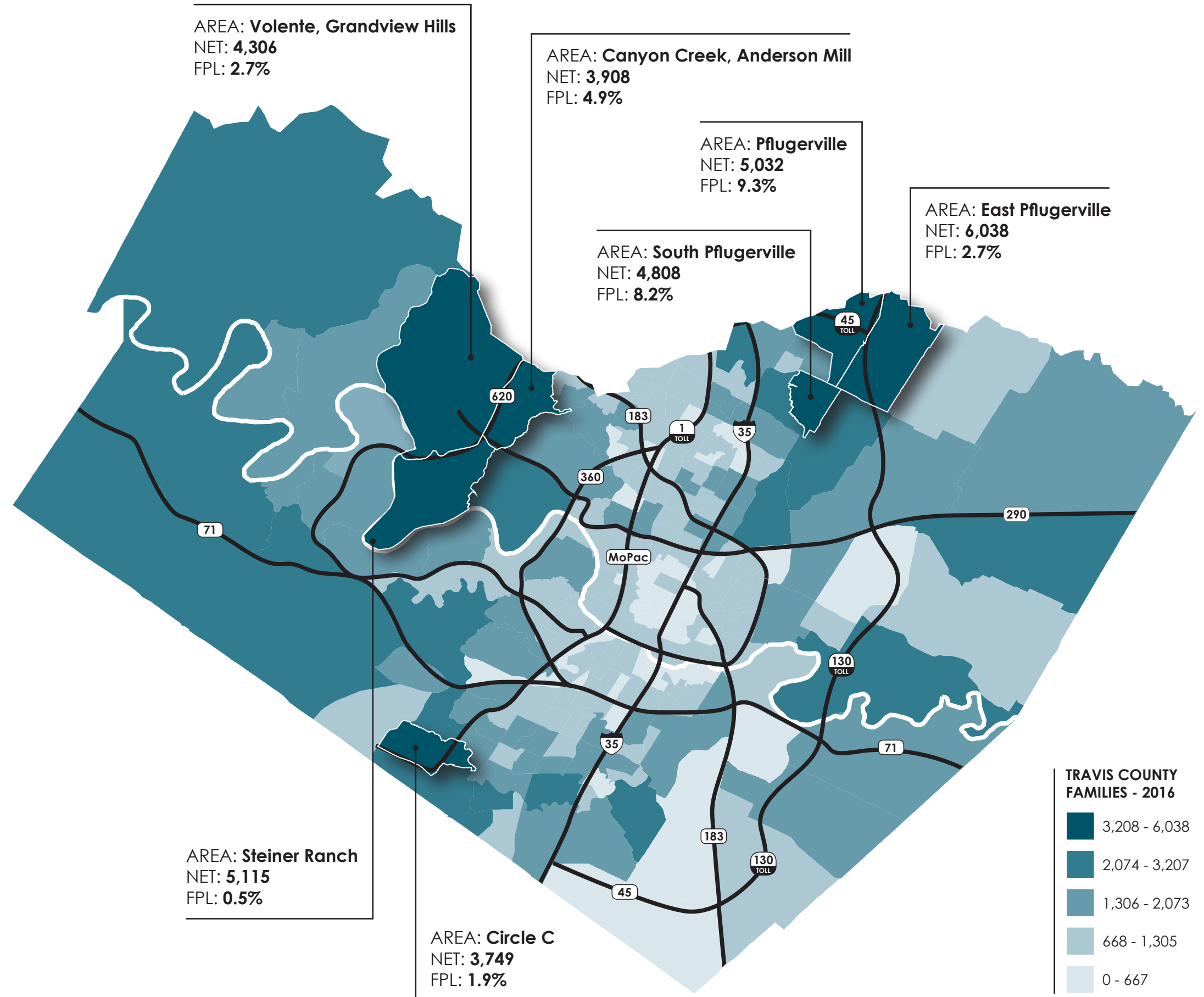

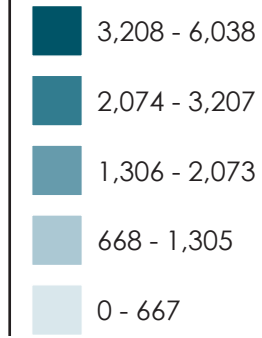

TRAVIS COUNTY FAMILIES IN POVERTY —2017

There are an estimated 33,061 Travis County families living in poverty in 2017. This represents 12 percent of all families in Travis County.

The greatest concentrations of families in poverty reside to the north, east and south of Austin's central core. Of the 10 census tracts with the highest concentrations of families in poverty, none are located in East-Central Austin—an area that historically housed large numbers of Austin's low-income and minority populations.

These 10 census tracts are home to 17,733 total families, of which 33 percent (5,872) are living in poverty. These 10 census tracts also host nearly 18 percent of the county's total families in poverty.

In Travis County, the highest concentrations of poverty do not align with high concentrations of families. None of the high-poverty census tracts highlighted on this page are among those with the highest number of total families.

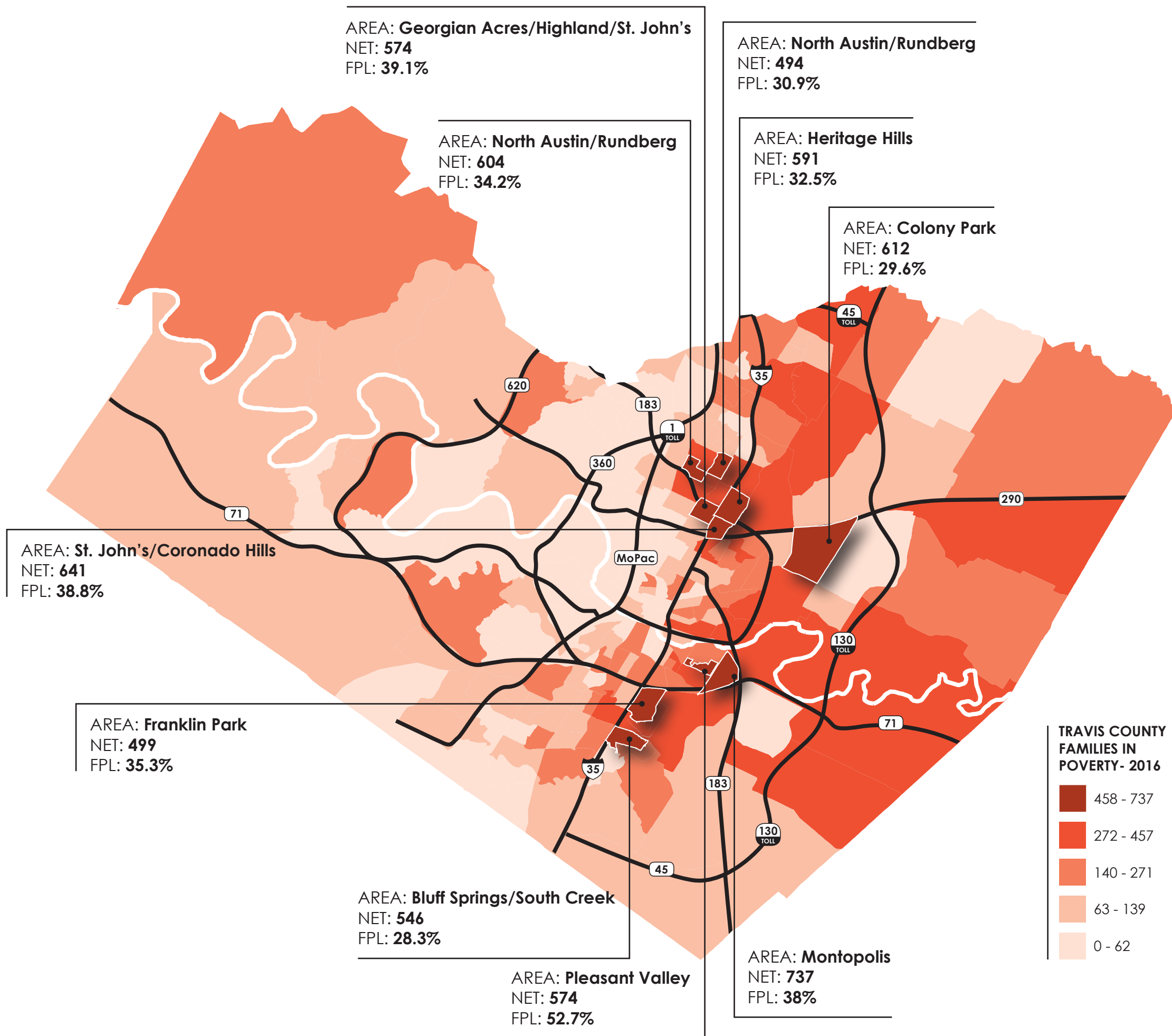

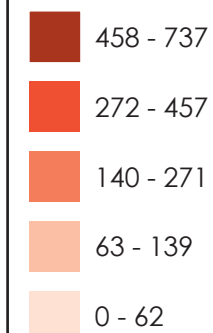

CHANGE IN TRAVIS COUNTY FAMILIES —2017-2022

The total number of families in Travis County is projected to reach 303,410 by 2022—an increase of 27,688 families (10 percent) from 2017.

The greatest increases in families will occur in Pflugerville and Northwest Austin. These areas are also among those with the greatest concentrations of families in 2017 (see Page 7).

The five census tracts with the greatest increases (highlighted to the right) are projected to experience an increase of 3,145 families, approximately 11 percent of the county's total growth during the next five years.

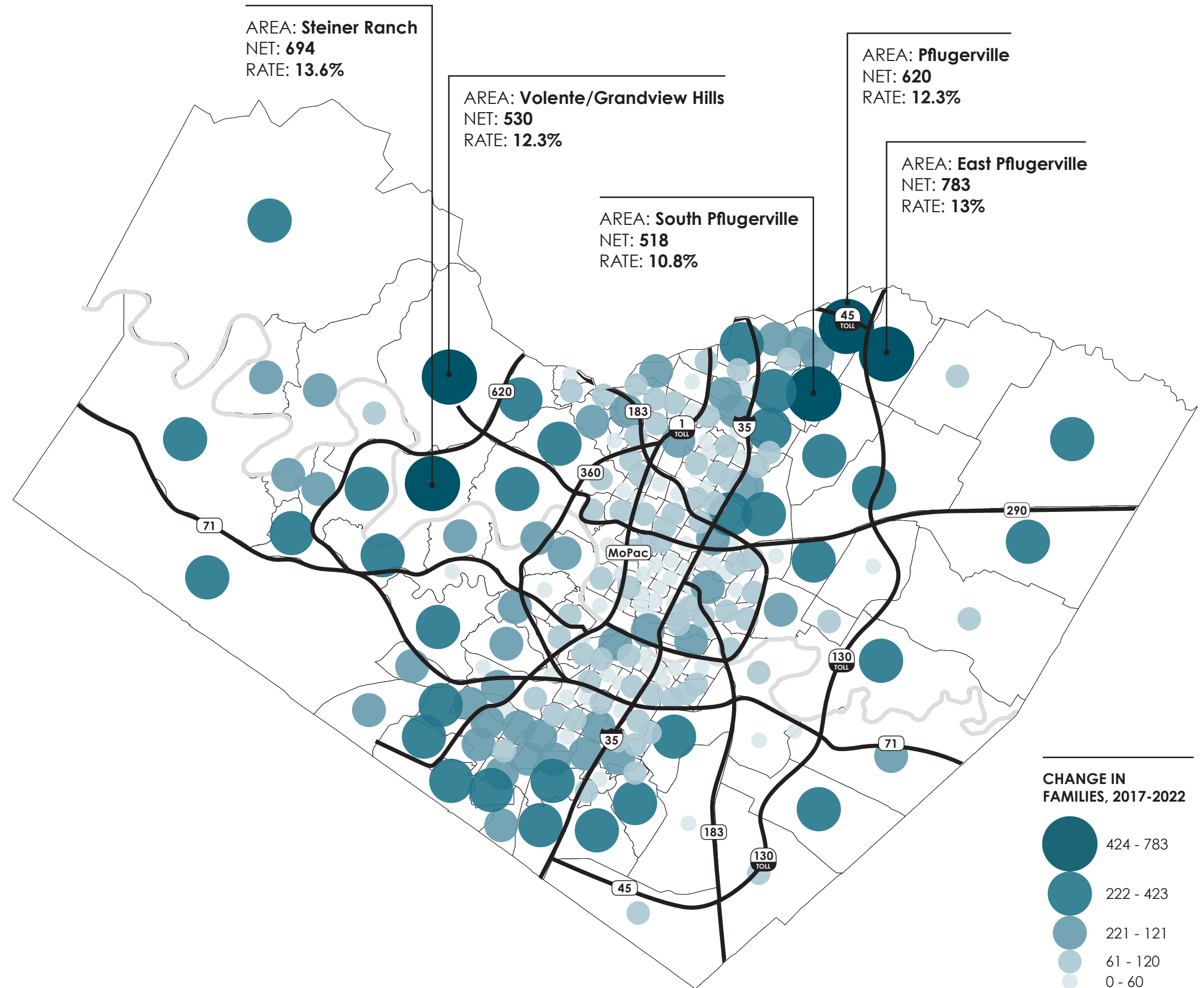

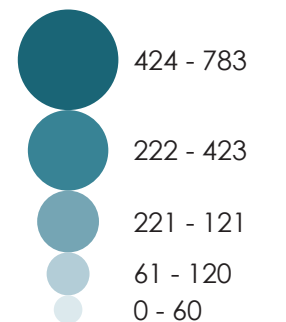

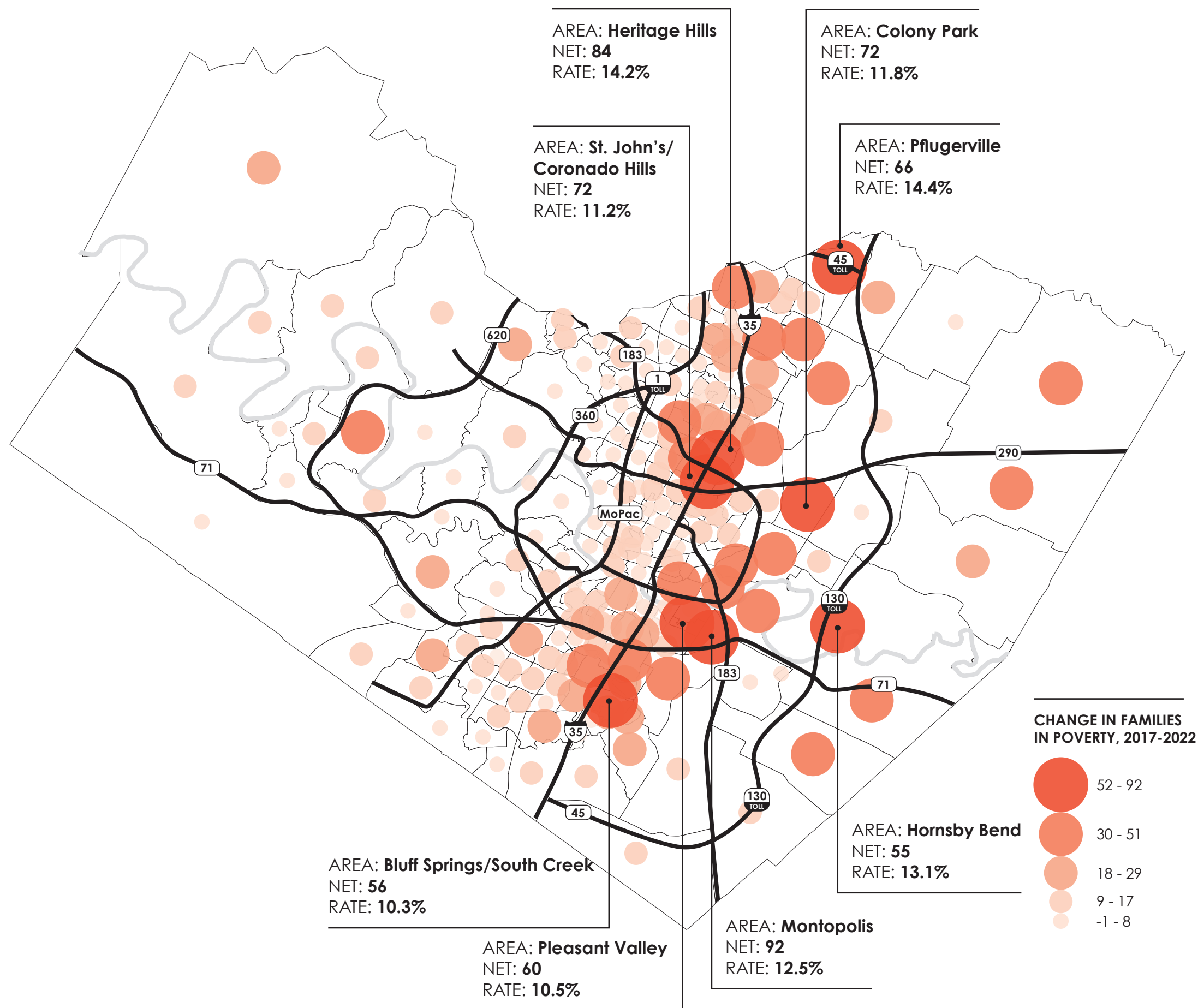
CHANGE IN TRAVIS COUNTY FAMILIES IN POVERTY—2017-2022

The total number of families living in poverty in Travis County is projected to reach 36,541 by 2022—an increase of 3,480 families (10.5 percent) from 2017.

The greatest increases of families in poverty are projected to occur in census tracts located east of I-35, including North Austin, South Austin, and formerly rural areas of Pflugerville and Hornsby Bend.

The eight census tracts with the greatest increases (highlighted to the left) are projected to experience an increase of 557 families in poverty, approximately 16 percent of the county's total growth.

In most cases, the census tracts experiencing the highest rates of total family growth (Page 8), do not align with those projected to see the greatest spikes in families in poverty. There is, however, one exception: Pflugerville contains the only census tract projected to experience one of the highest increases in total families and families in poverty.

HIGH CONCENTRATIONS OF TRAVIS COUNTY FAMILIES IN POVERTY —2022

The total number of families living in poverty in Travis County is projected to reach 36,541 by 2022.

The greatest concentrations of families in poverty are projected to reside in the 16 census tracts highlighted on this page. These 16 census tracts will be home to 9,344 families in poverty—more than 25 percent of the county's total families in poverty.

Further analysis shows these areas of high concentrations of poverty can be divided into three subsections:

CURRENT HIGH CONCENTRATIONS/HIGH INCREASE (PAGE 11)

- These areas are among those with the highest concentrations of poverty in 2017 (458+ families in poverty).
- These areas are projected to experience the highest increases in families in poverty from 2017 to 2022 (56-92 additional families in poverty).

CURRENT HIGH CONCENTRATIONS/MODERATE INCREASE (PAGE 12)

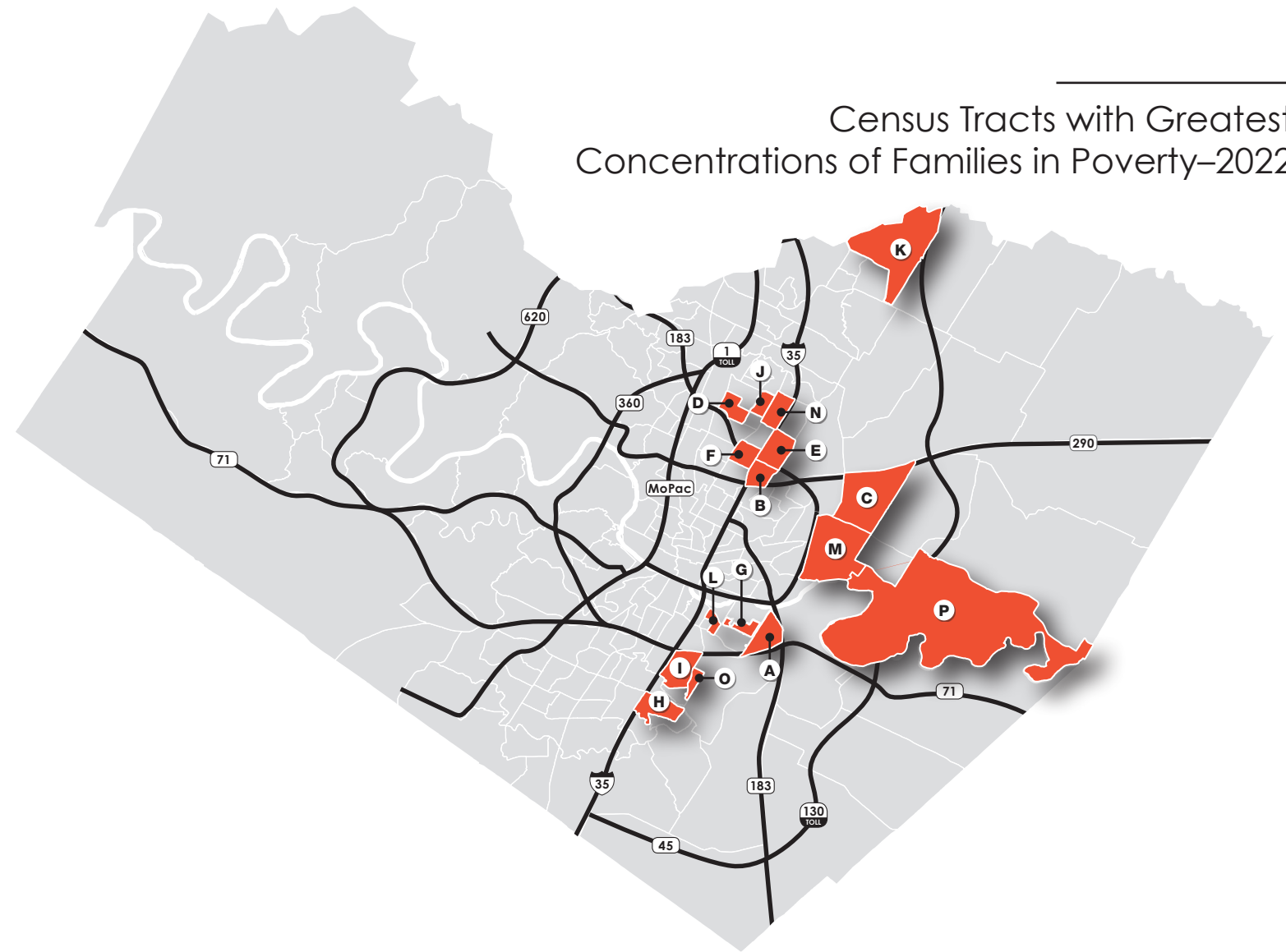
- These areas are among those with the highest concentrations of poverty in 2017 (458+ families in poverty).
- These areas are projected to experience moderate increases in families in poverty from 2017 to 2022 (27-43 additional families in poverty).

CURRENT MODERATE CONCENTRATIONS/HIGH CONCENTRATIONS IN 2022 (PAGE 13)

- These areas are among those with moderate concentrations of poverty in 2017 (272-457 families in poverty).
- These areas are projected to be among those with the highest concentrations of poverty in 2022 (458+ families in poverty).
- These areas are projected to experience moderate and high increases in families in poverty from 2017 to 2022 (26-66 additional families in poverty).

HIGH CONCENTRATIONS OF TRAVIS COUNTY FAMILIES IN POVERTY —2017 AND 2022 (HIGH INCREASE)

The six highlighted areas on this page are among those experiencing the highest concentrations of poverty in 2017 (458+ families in poverty). These tracts are simultaneously projected to experience the highest increases in families in poverty over the next five years (56-92 additional families in poverty).

In **2022**, it is projected these six census tracts will:

- Be home to **11,735 families**—approximately **3.9 percent** of the county's total families.
- Be home to **4,137 families in poverty**—approximately **11.3 percent** of the county's total families in poverty.
- Count **35 percent of families as living in poverty**—almost **three times** the county's overall rate.¹

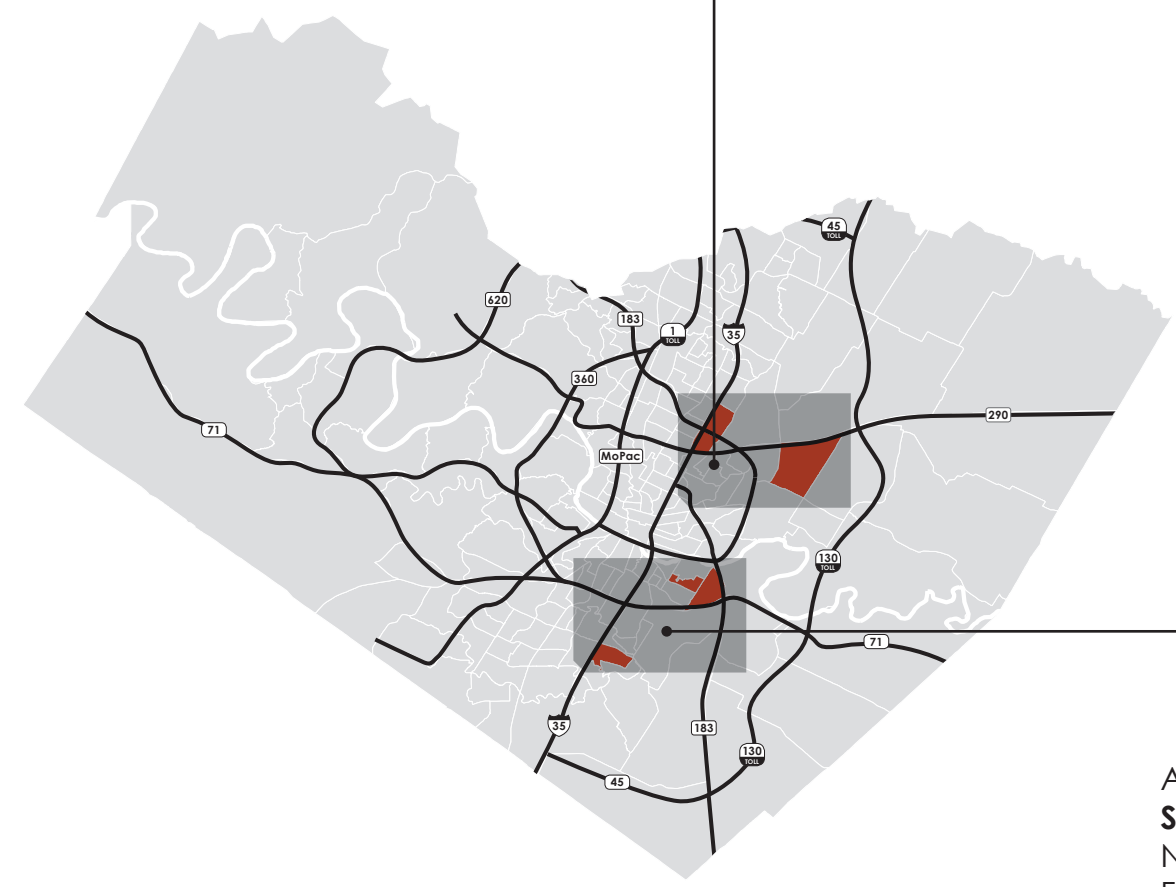

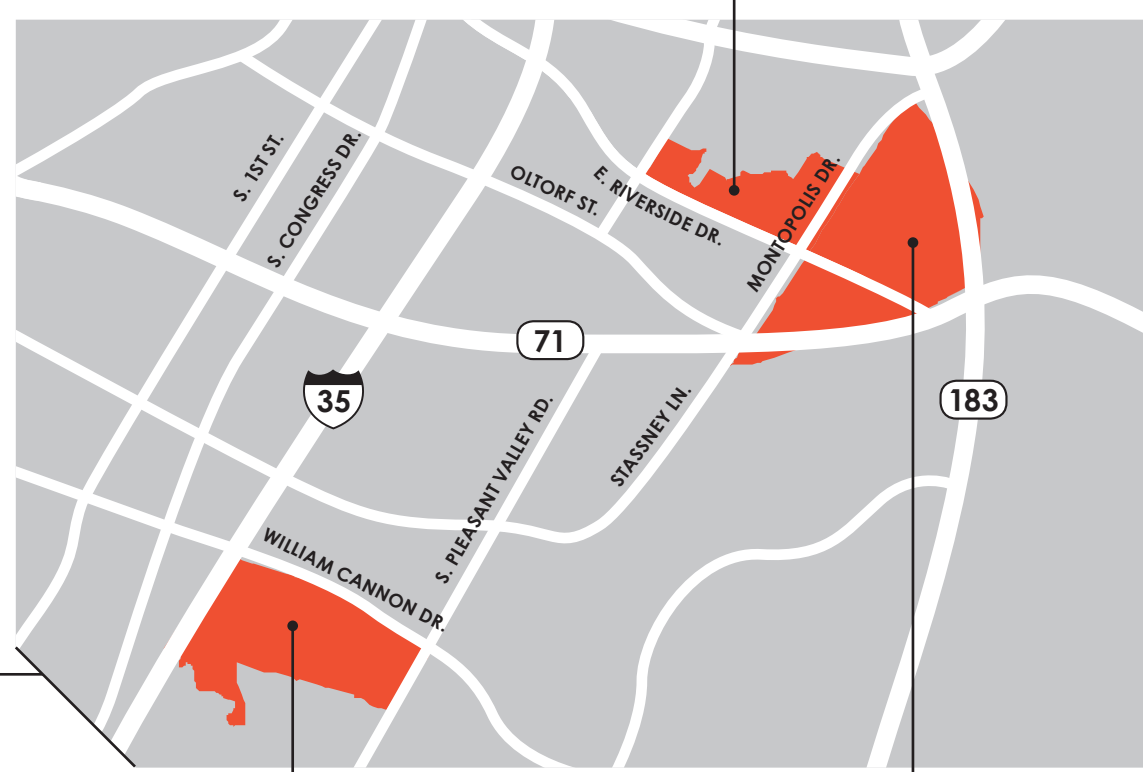

- Be home to **6,657 families**—approximately **2.2 percent** of the county's total families.
- Be home to **2,316 families in poverty**—approximately **6.3 percent** of the county's total families in poverty.
- Count **35 percent of families as living in poverty**—almost **three times** the county's overall rate.¹

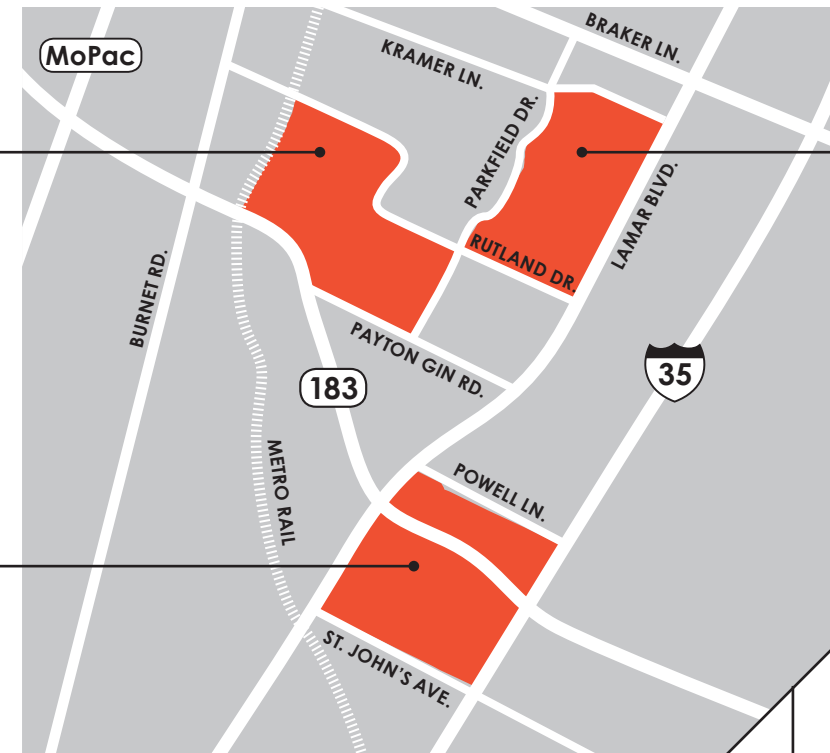

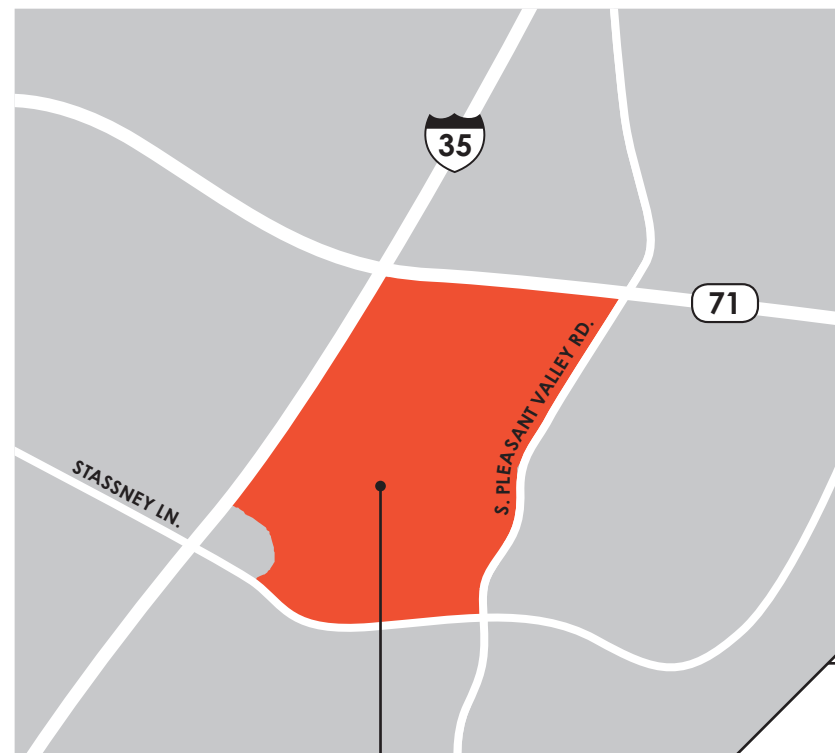

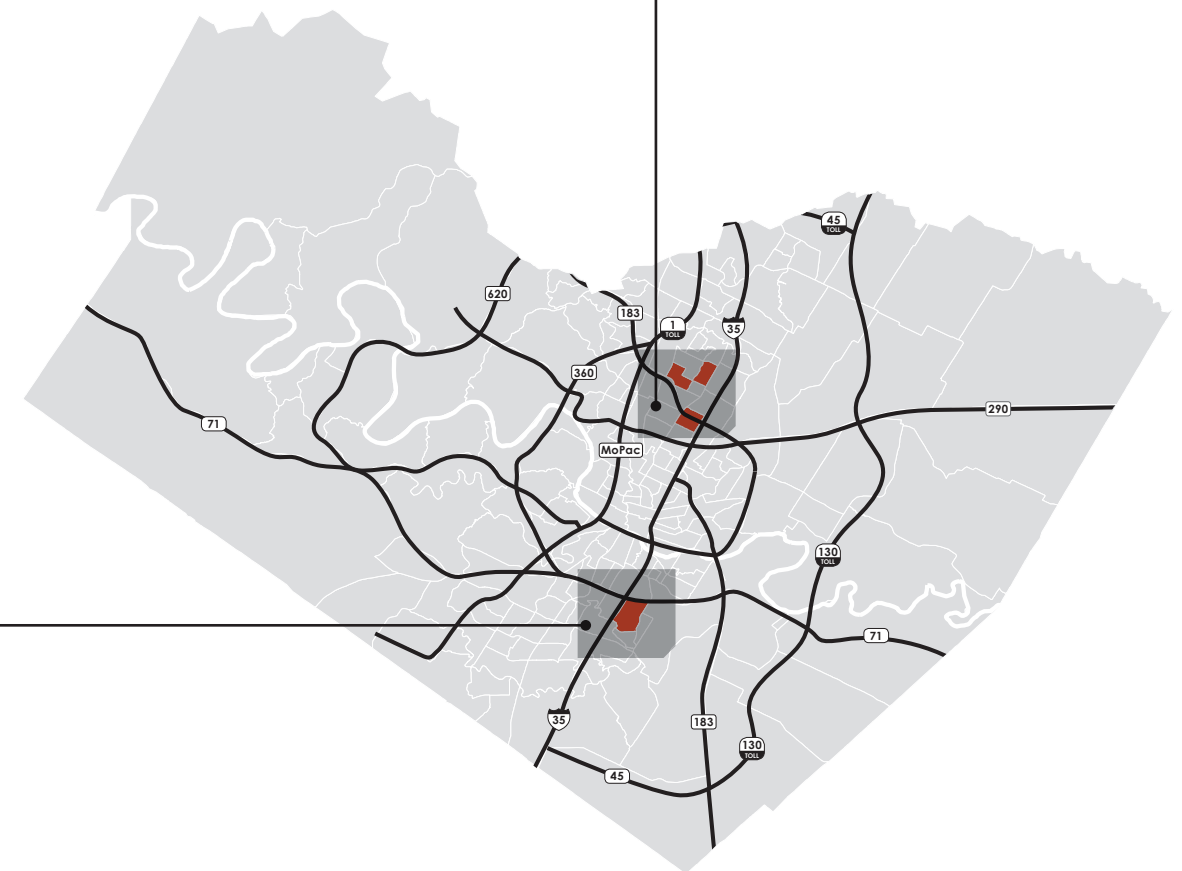

The six highlighted areas on this page are among those experiencing moderate concentrations of poverty in 2017 (272-457 families in poverty). These census tracts are projected to be among those experiencing moderate to high increases in families in poverty over the next five years (22-66 additional families in poverty). As a result of the increases, these areas are projected to be among those with the highest concentrations of poverty in 2022 (458+ families in poverty).

In **2022**, it is projected these six census tracts will:

- Be home to **14,055 families**—approximately **4.6 percent** of the county's total families.
- Be home to **2,891 families in poverty**—approximately **7.9 percent** of the county's total families in poverty.
- Count **21 percent of families as living in poverty**—almost **double** the county's overall rate.¹

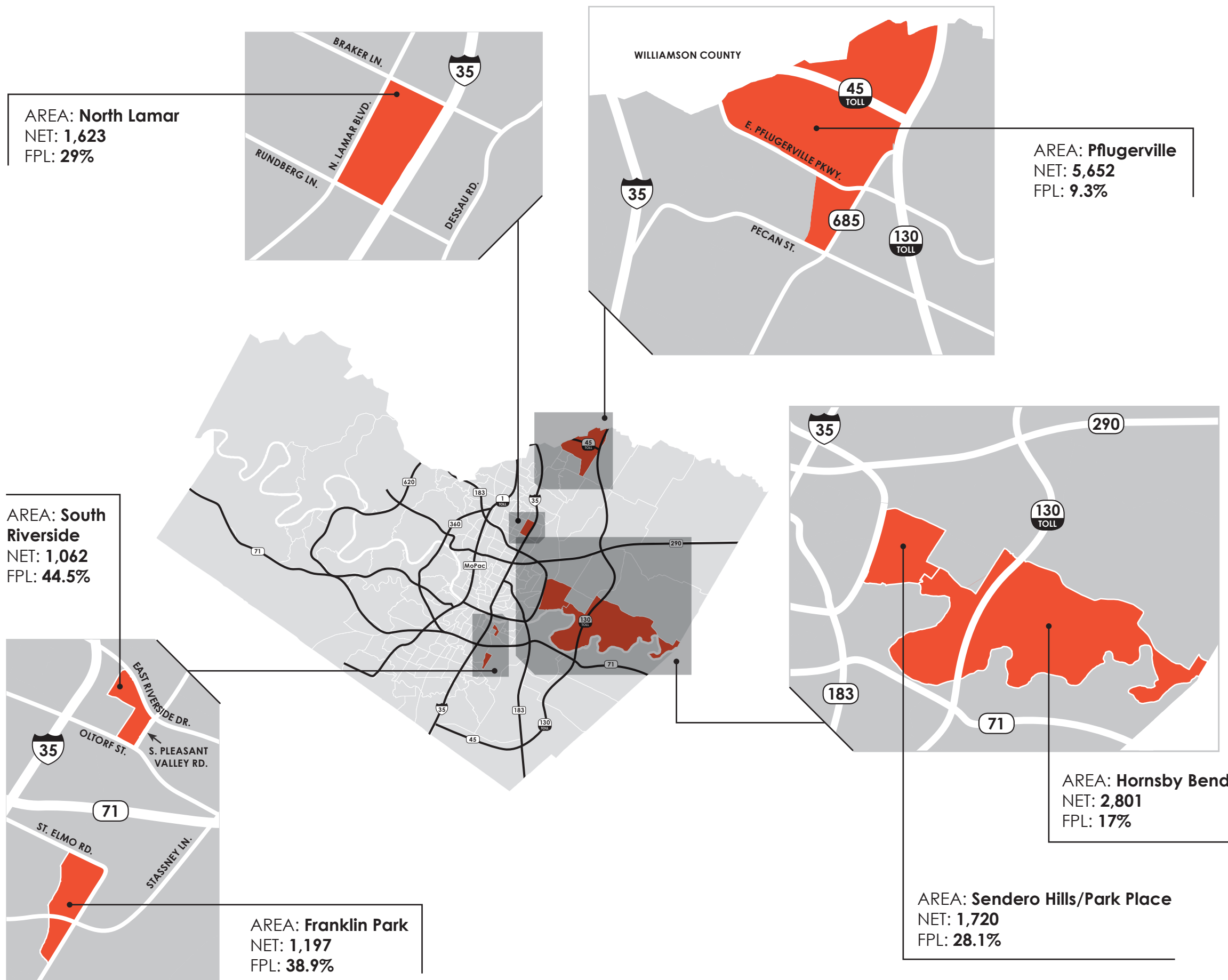

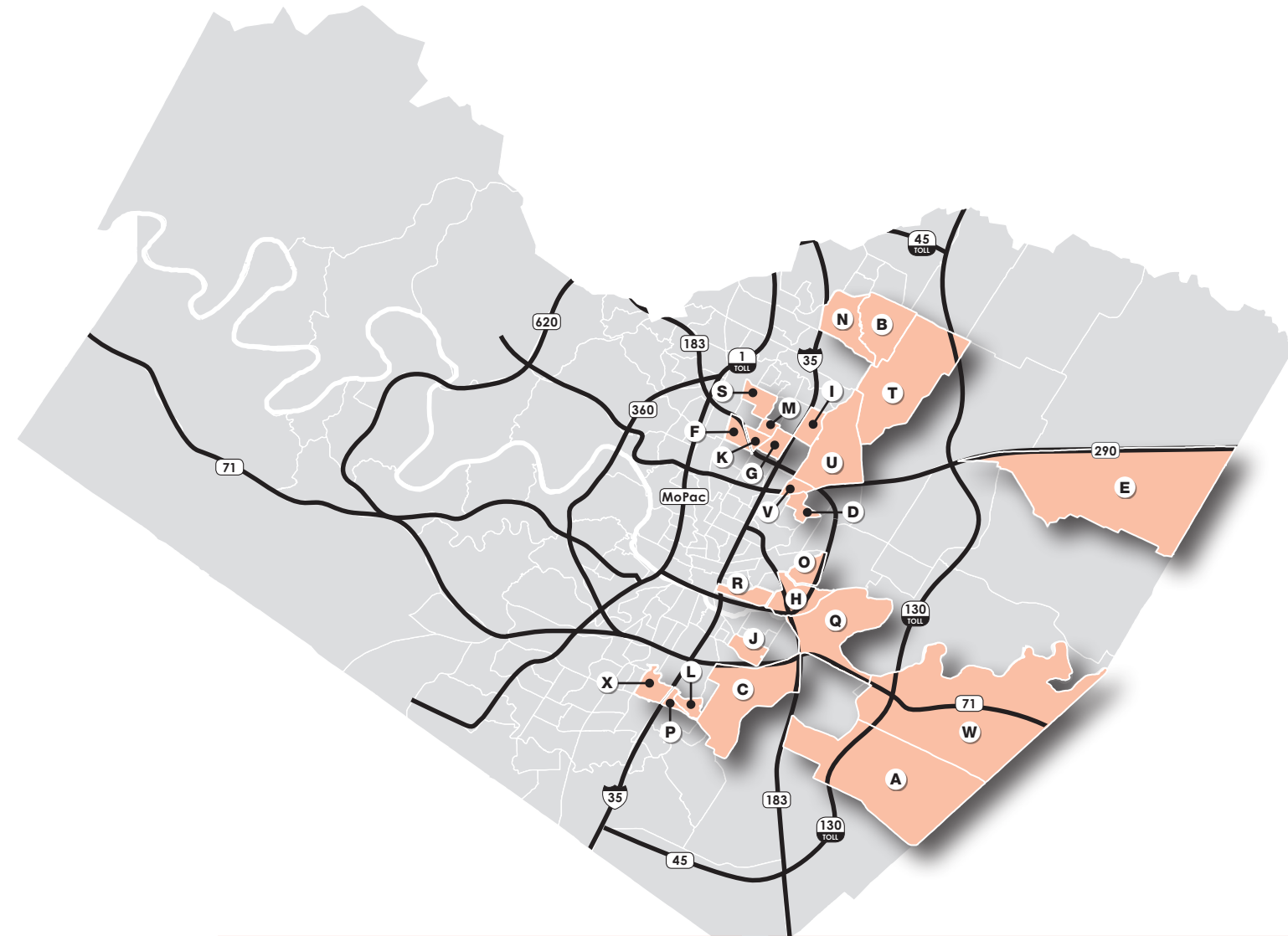
Pages 11-14 focused on the 16 census tracts projected to have the largest concentrations of poverty in 2022 (more than 458 families in poverty). It is also important to identify and analyze those areas with slightly less—but still significant—numbers of families in poverty.

The 24 census tracts identified on this page fall into the second-highest category of families in poverty—defined in this report as “moderate concentrations” of poverty (312-447 families in poverty).

In **2022**, it is projected these 24 census tracts will:

- Be home to **43,380 families**—approximately **14.3 percent** of the county’s total families.
- Be home to **8,877 families in poverty**—approximately **24.3 percent** of the county’s total families in poverty.
- Count **20 percent of families as living in poverty**—almost **1.5 times** the county’s overall rate.¹

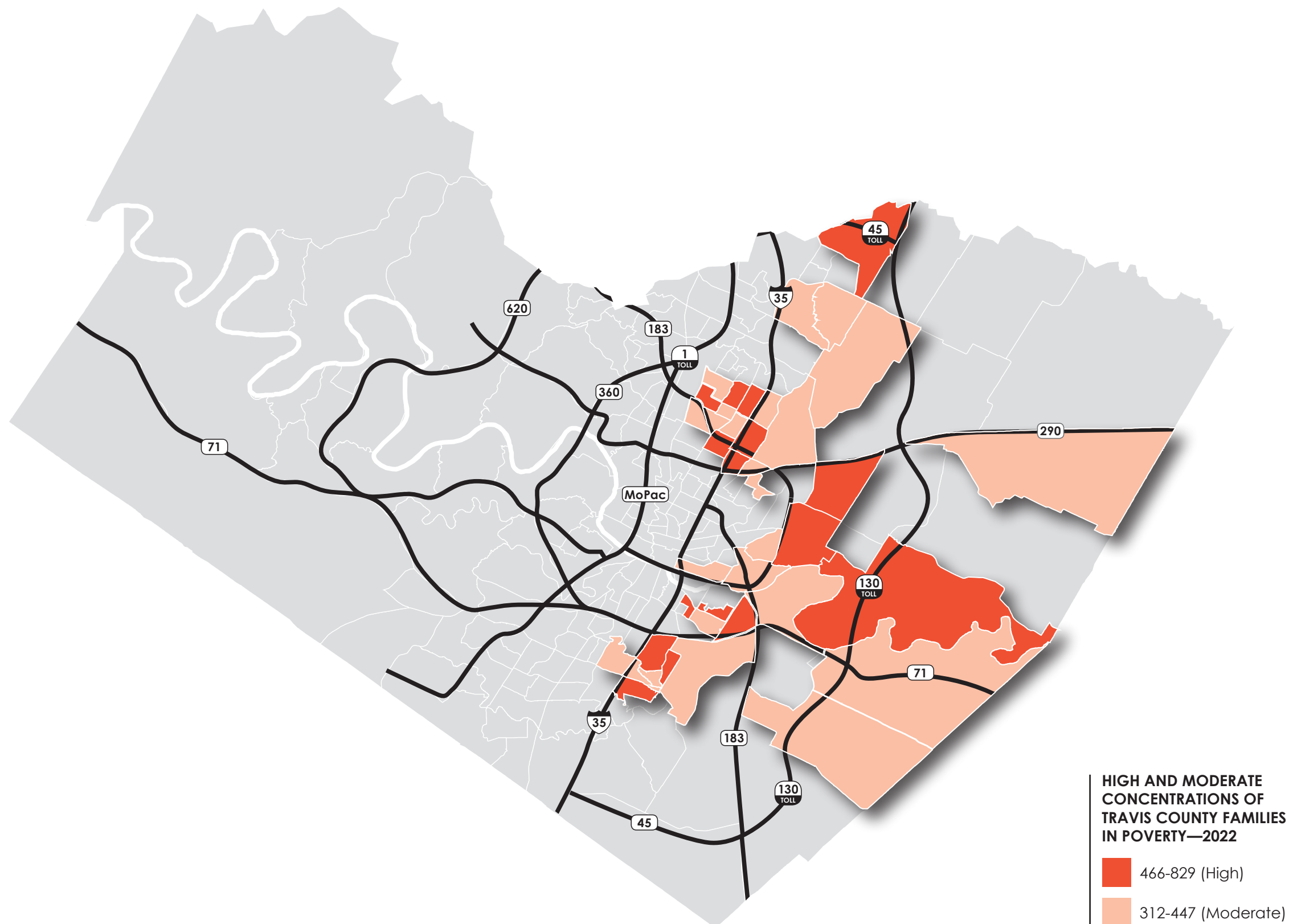

HIGH AND MODERATE CONCENTRATIONS OF TRAVIS COUNTY FAMILIES IN POVERTY—2022

The combined 2022 projects of high and moderate concentrations of families in poverty more clearly shows the needs of Travis County's low-income and uninsured populations. These areas represent 40 of Travis County's 217 census tracts. In the next section of this report, these tracts will be divided into focus areas, defined by distinct topographic boundaries.

Combined, in **2022** it is projected these 40 census tracts will:

- Be home to **75,827 families—25 percent** of the county's total families.
- Be home to **18,221 families in poverty—49.9 percent** of the county's total families in poverty.
- Count **24 percent of families as living in poverty—double** the county's overall rate.¹
- Average **456 families in poverty—2.7 times** the county's overall average.²

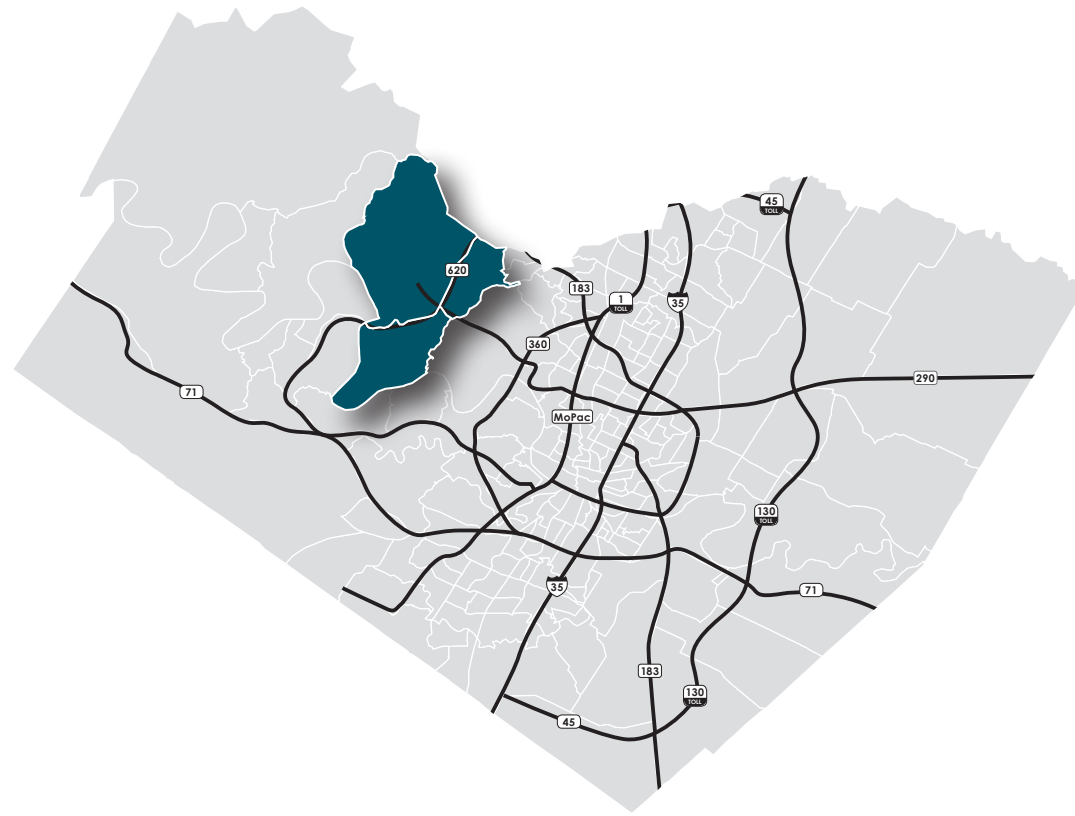

CONCLUSIONS: TRAVIS COUNTY FAMILIES, 2017-2022

With Austin's thriving economy at its center, Travis County continues to be a magnet for growth. There are no indications the migration of new families to Travis County over the next five years will slow. However, a scarcity of real estate and escalating housing costs in and around Austin's central core are pushing many families to the periphery of Austin. This report projects Travis County's greatest increases in families over the next five years will occur outside Austin city limits in:

- Northwest Travis County (Steiner Ranch, Volente, Grandview Hills)
- Pflugerville



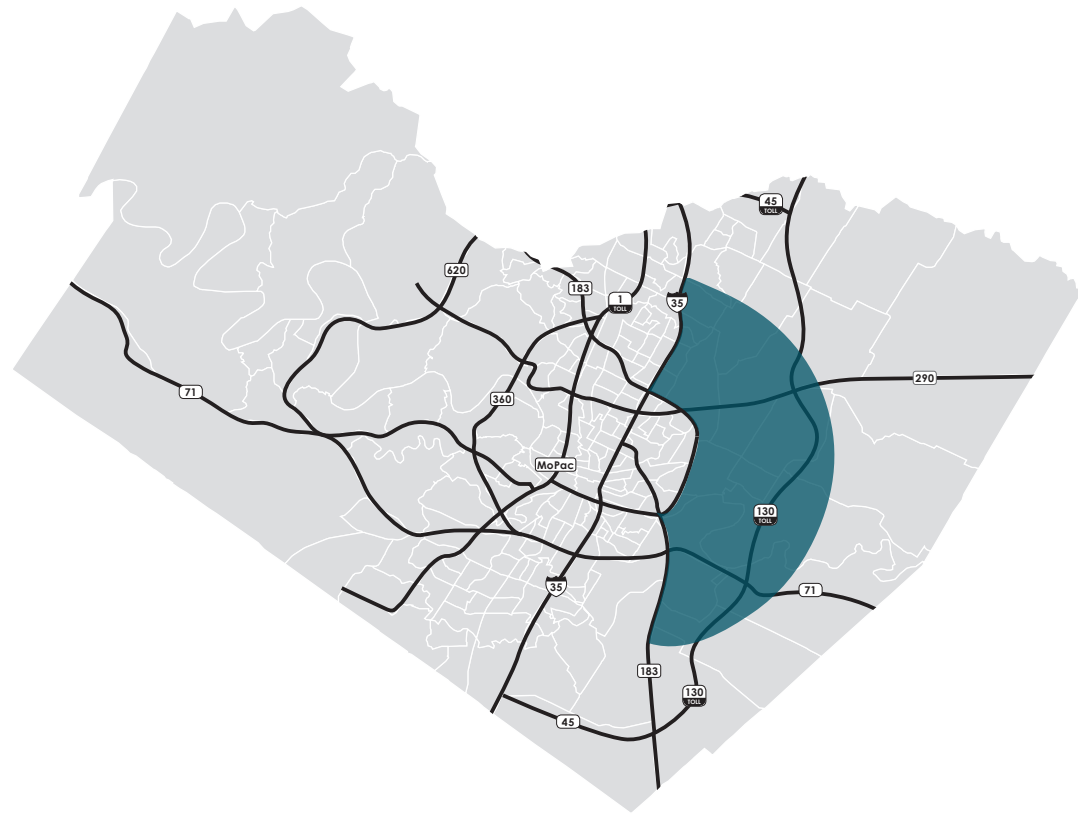
Northwest Travis County

Due to the current and projected low numbers of families in poverty in Northwest Travis County, it appears this area will experience growth primarily in middle- and upper-income families. The area is also served by high performing schools within Round Rock ISD and Leander ISD, which are an obvious attraction to families with children.



Pflugerville

The city of Pflugerville and the surrounding unincorporated areas of Travis County are projected to experience high rates of growth in total families, as well as families in poverty. As was reported in Central Health's 2015 Demographic Report, Pflugerville is projected to have the greatest concentrations of African American and Asian residents by 2019, as well as the second-greatest concentration of Hispanic residents. These patterns indicate Pflugerville continues to be a destination for many of the families displaced by the rising costs of living in East-Central Austin.



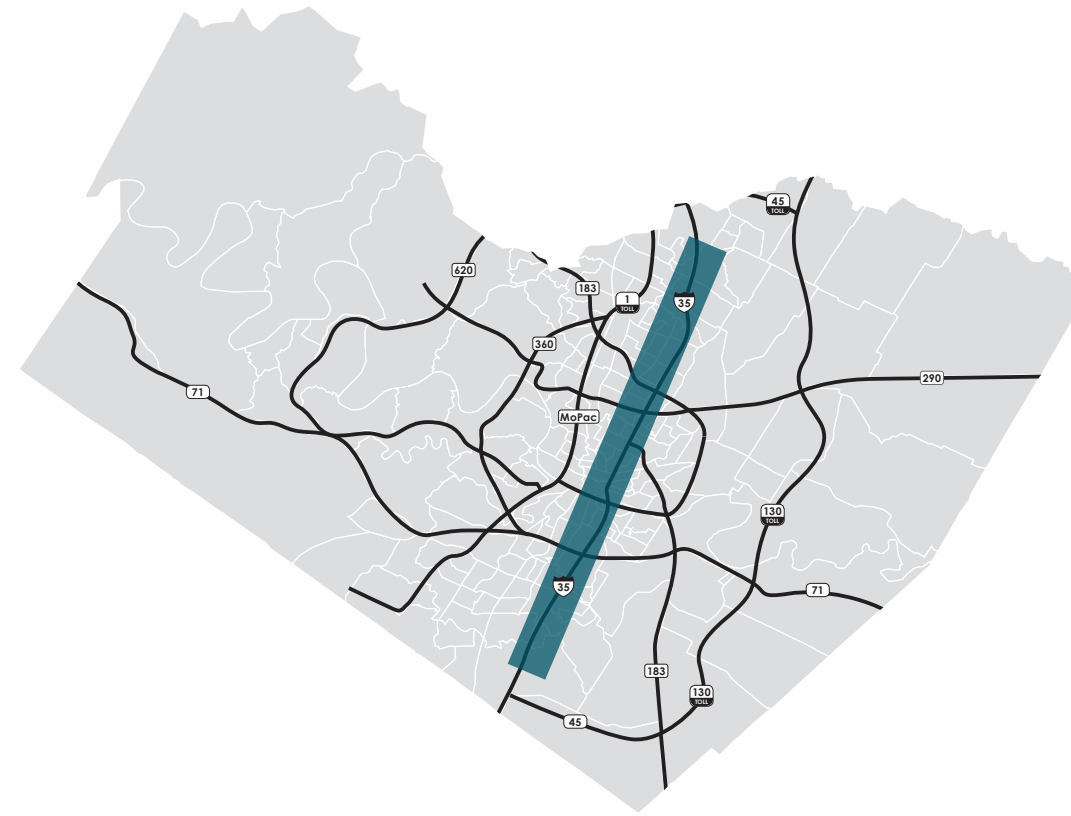
Eastern Crescent

The term “Eastern Crescent” is commonly referred to when describing the pattern of gentrification and displacement of low-income Austin residents to suburban communities in eastern Travis County. Laid out on a map, the Eastern Crescent roughly follows the pattern of a backwards “C,” beginning at the top in the Rundberg area, then extending through Pflugerville, Colony Park, Del Valle and Montopolis, before ending in the Dove Springs area.

The effect of this pattern is a crescent extending north, east and south of East Central Austin. Due to institutional segregation, for decades Central Austin east of I-35 was the home to Austin and Travis County’s largest concentrations of African American and Hispanic residents. Gentrification and market costs, however, are changing the demographics and income levels of these communities:

Among the 10 census tracts with the highest concentration of families in poverty in 2017, none reside within the East Central Austin area defined by Hwy. 290 to the north; U.S. 183 to the east; the Colorado River to the south; and I-35 to the west.

- The Rundberg area contains the only remaining neighborhoods west of I-35 with significant concentrations of poverty (2017 and 2022)
- All eight of the census tracts projected to experience the highest increases of families in poverty are located east of I-35, south of the Colorado River and north of Hwy. 290.
- Five of the census tracts projected to have high and moderate concentrations of families in poverty in 2022 extend to Travis County’s border



I-35 Corridor

A high number of families in poverty reside along the I-35 corridor, particularly in the North Austin/Rundberg area; the Franklin Park area south of Hwy. 290; and the Montopolis/Pleasant Valley neighborhoods in Southeast Austin. All of these areas also include census tracts projected to be among those with the highest concentrations of poverty in five years. The data in this report supports the need to continue focusing resources for the communities along the I-35 corridor, even as new areas of need are identified in other parts of Travis County.



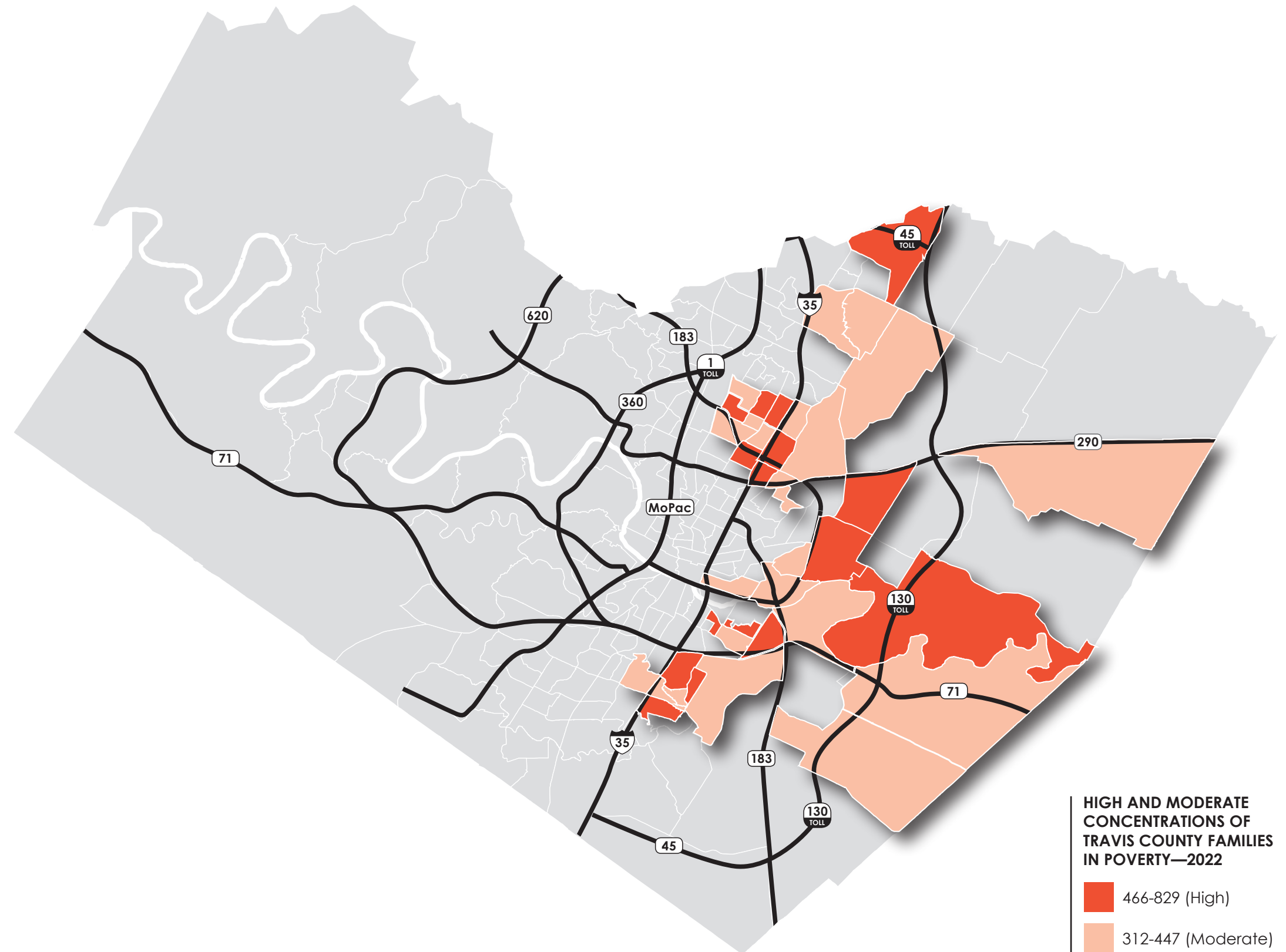

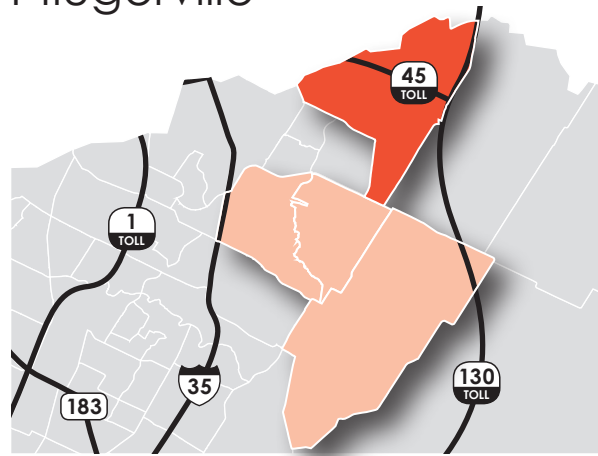
The purpose of this section is to focus in further on the 40 Travis County census tracts projected to have high and moderate levels of poverty in 2022. The analysis in this section will:

- Examine access to health care facilities (primary care, urgent care and hospitals) within each focus area
- Examine transportation issues—such as access to public transportation and the prevalence of households with no vehicles— affecting low-income families within the focus areas
- Examine the availability of subsidized public housing dedicated to families in poverty within each focus area

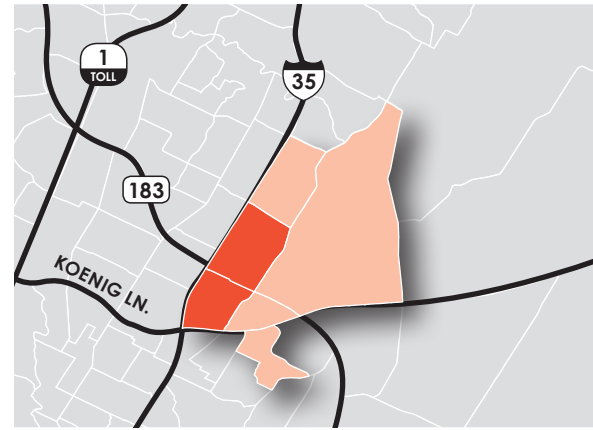

Race/Ethnicity

Hispanics and Latinos are the dominant race/ethnicity in the low-income areas of Travis County, representing 58.5 percent of the population in the high-poverty and moderate-poverty census tracts. In comparison, the Hispanic/Latino demographic accounts for 32.5 percent of Travis County's overall population.

In the nine focus areas highlighted in this report, the rate of Hispanics/Latinos ranges from 71 percent in South Austin to 36 percent in Pflugerville. In all but two of the focus areas highlighted in this report (Pflugerville and Manor) Hispanics/Latinos represent more than 50 percent of the total population.

As noted in the introduction to this report (Page 2), the Hispanic/Latino demographic group also represents two-thirds (66.5 percent) of the Community Care Collaborative's patient population. Combined, the patient data and the demographic reporting support the need to monitor and assess the state of safety-net health care as well as supportive services in the areas of Travis County with high concentrations of Hispanics and Latinos.

The White demographic represents Travis County's largest race/ethnicity, accounting for 48.9 percent of the total population. Within the census tracts with high and moderate concentrations of poverty, the rate of white residents ranges from 30.5 percent (Pflugerville) to 9.7 percent (Colony Park). Still, the White demographic represents the second largest race/ethnicity in the census tracts containing high and moderate concentrations of poverty, accounting for 19.6 percent of the population.

None of the focus areas highlighted in this report contain a census tract with a White population matching or exceeding the county's overall rate. However, the Wooten neighborhood in North Central Austin, and the Pleasant Hill/South Congress neighborhood in South Austin count White populations in excess of 40 percent.

The African American population is the third largest demographic group within this report's focus areas, representing 13 percent of the population. Countywide, African Americans represent 8 percent of the population.

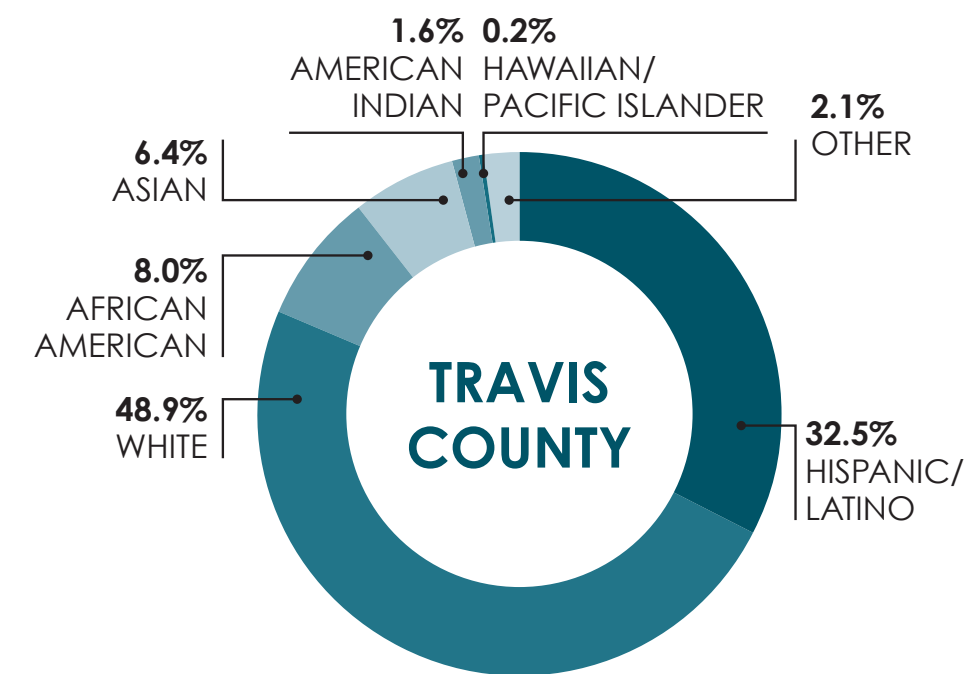
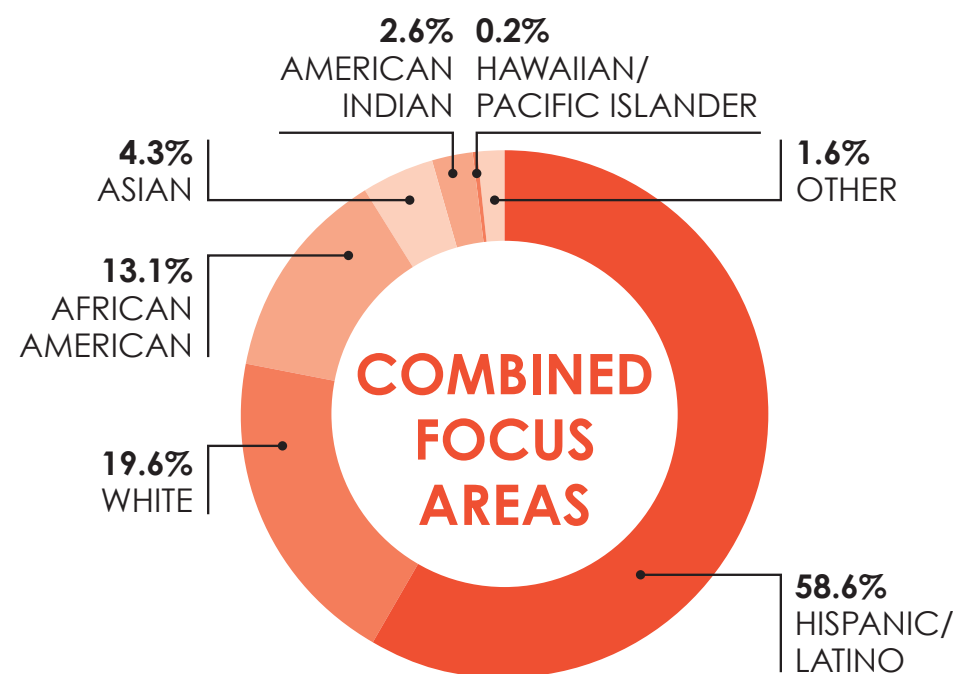
In the focus areas highlighted in this report, the percent of African Americans ranges from 25.1 percent (Manor) to 6.4 percent (South Austin).

The greatest concentrations of African American residents in Travis County now reside outside the city of Austin, particularly in the Pflugerville, Colony Park and Manor focus areas. Going forward, services designed to meet the unique health care needs of the African American population should be targeted toward these areas.

The Asian demographic represents 6.4 percent of Travis County's total population, but just 4.3 percent of the population within the focus areas highlighted in this report. The percent of Asian residents in the nine focus areas ranges from 11.1 percent (Pflugerville) to 0.4 percent (Colony Park).

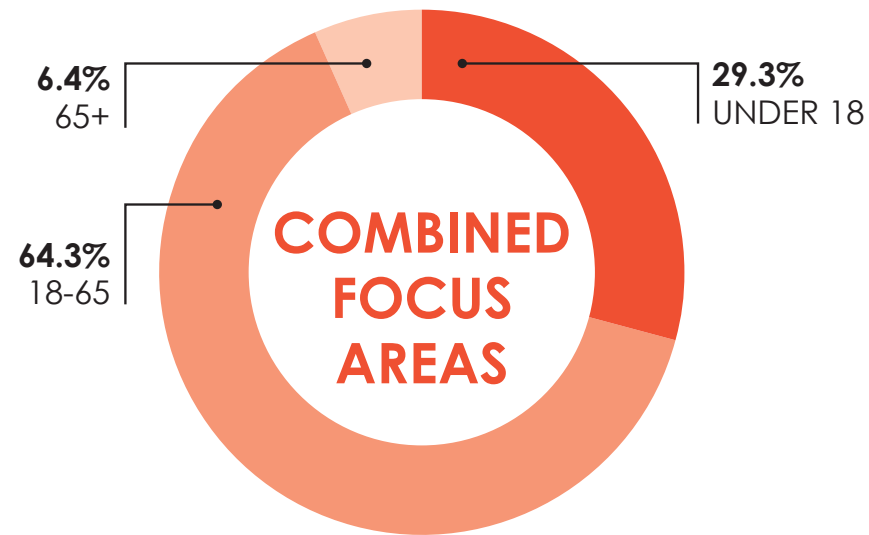
Pflugerville is the only focus area whose percentage of Asian residents exceeds the county's rate. In fact, South Pflugerville contains the most Asian residents of any census tract in Travis County.

An interesting byproduct of the gentrification occurring in Austin is the creation of racial diversity in outlying suburban communities. While much of Austin is now segmented into areas of majority Hispanic/Latino or majority White populations, there is no majority population in either Manor or Pflugerville (Pages 24 and 38). The Pflugerville focus area is particularly diverse, with significant concentrations of Hispanic/Latino, White, African-American and Asian residents.

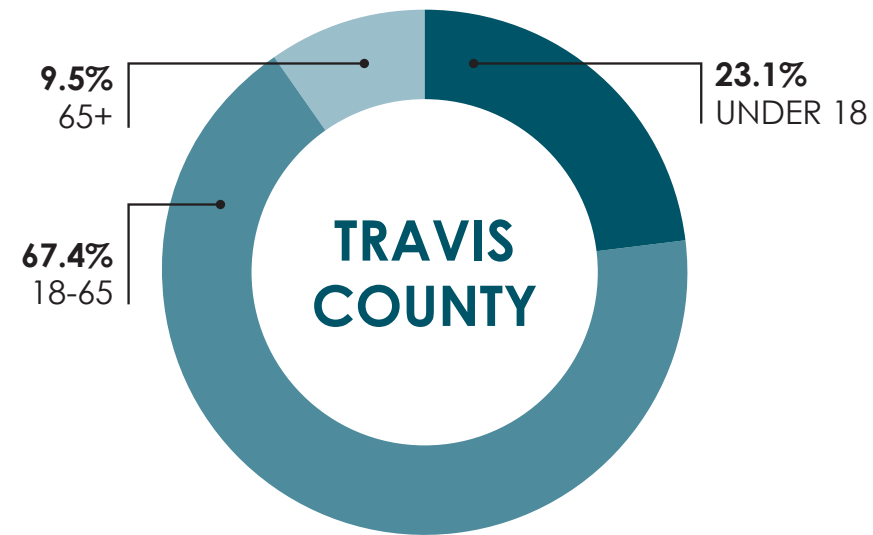


Age

The rate of children ages 0-17 is significantly higher in the areas of Travis County experiencing high and moderate levels of poverty. Combined, the percentage of children within the nine focus areas highlighted in this report represent 29.3 percent of the population—6 percent higher than the county’s overall rate of 23.1 percent.

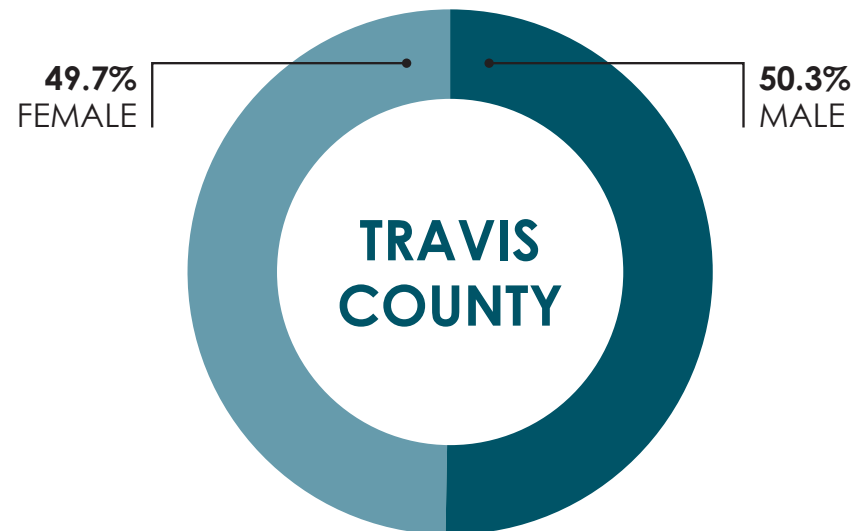
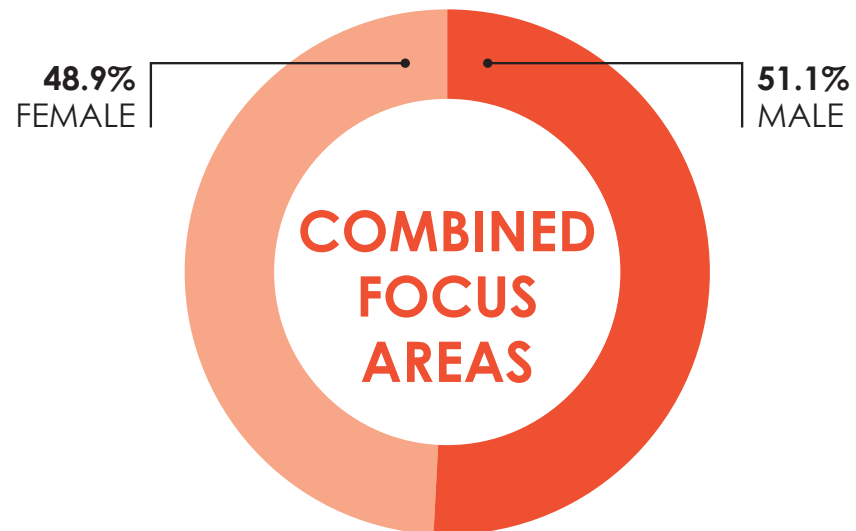


The higher percentage of children in low-income areas reduces the rate of adults ages 18-64 and 65 and over. The percent of age 18-64 adults is 64.3 percent—3 percent lower than the county’s rate (67.4 percent). The percent of adults age 65 and over is 6.4 percent—also 3 percent below the county’s rate (9.5 percent).



Gender

The percentage of males within the nine focus areas highlighted in this report (51.1 percent) is 0.8 percent higher than the countywide rate (50.3 percent). Among these focus areas, only two—Pflugerville and Manor—have majority female populations.

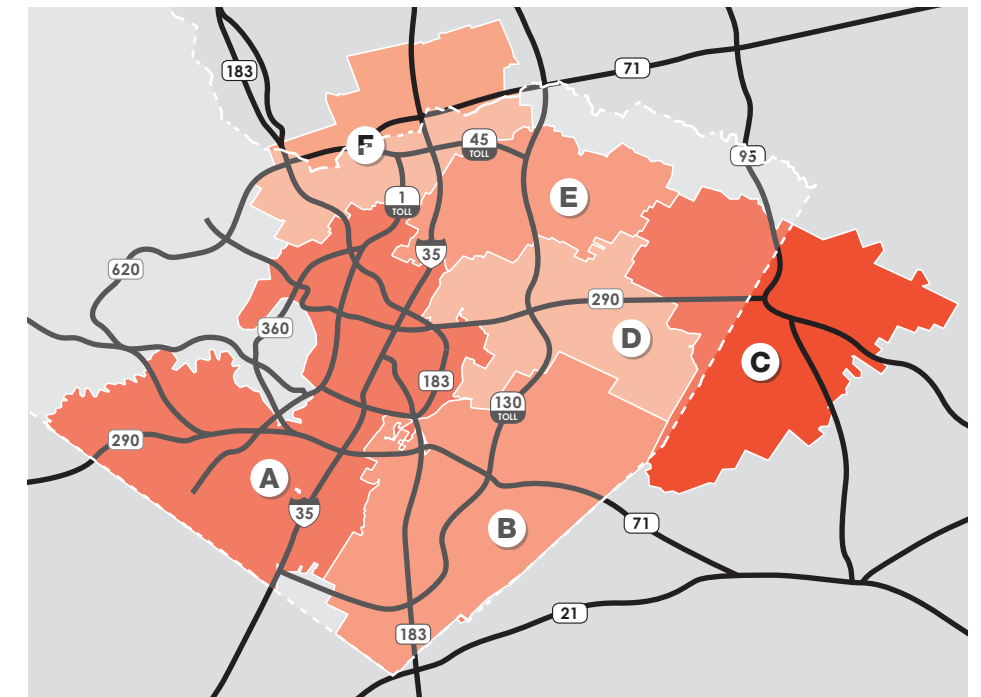
Schools

School district service areas are not contiguous or limited by other geopolitical boundaries, such as city or county boundaries. As such, the nine focus areas in this report are served by six school districts:

Schools and school districts serve as important partners in Central Health’s efforts to provide health care services to Travis County’s low-income and uninsured population. Central Health works and contracts with health care providers offering services at many local schools, including primary care and behavioral health care.

Six of the nine focus areas in this report are served by more than one school district, including the Pflugerville focus area, which is divided into four different school districts’ boundaries. This fact serves as a reminder that health care initiatives within the schools serving Central Health’s low-income and uninsured population—even within limited geographic areas—will require coordination through multiple independent school districts.

Transportation

This report focused on two aspects of transportation specifically related to residents with low incomes:

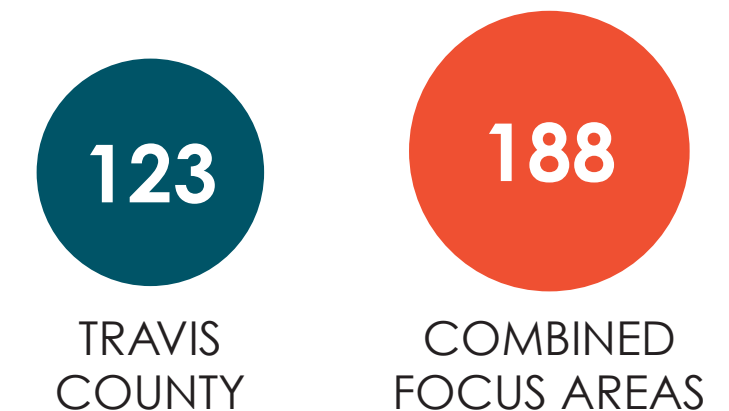
- Access to CapMetro bus routes
- Households without vehicles by census tract

Public transportation, or the lack thereof, becomes a more significant issue the farther a person is located from Austin’s central core. Because the majority of health care providers and social service assistance within Travis County is located in Austin, access to transportation is vital for low-income residents in rural or suburban communities. The focus areas most challenged by the lack of accessible and consistently operating public transportation are Colony Park, Del Valle, Manor and Pflugerville. Many of the census tracts within these focus areas have no public transportation services, or are limited to morning and night commuter bus routes.

Fortunately, the majority of the focus areas with limited public transportation have lower-than-average totals of households without vehicles. The most notable exception is the Hornsby Bend census tract located within the Colony Park focus area. Hornsby Bend counts 151 households without vehicles—28 more than the countywide average—and lacks any access to public transportation.

Subsidized public housing

Skyrocketing real estate values in Travis County have created an urgent need to develop and preserve subsidized public housing inventories. However, subsidized public housing is an ambiguous term dependent on an individual or family's income and size. For example, an individual experiencing homelessness may be best served by a studio apartment with on-site support services, whereas a middle-income family may be searching for assistance purchasing a home.

As such, there exists a myriad of definitions for what qualifies as subsidized public housing, and a number of federal, state, local and non-profit agencies working to support subsidized public housing programs, including:

- Foundation Communities
- City of Austin Neighborhood Housing and Community Development Department (NHCD)
- Housing Authority of the City of Austin (HACA)
- Housing Authority of Travis County (HATC)
- Texas Department of Housing & Community Affairs
- U.S. Department of Housing & Urban Development (HUD)

Combined, these public and non-profit entities oversee programs ranging from owning and managing low-income housing communities, to incentivizing developers through tax credits to build subsidized public housing units, to providing vouchers to offset residents' rental costs.

Most of the local subsidized public housing programs are tiered by a household's income in comparison to the median family income (MFI) levels for the Austin-Round Rock metropolitan statistical area (MSA). The MFI for a family of four in Travis County is calculated at \$81,400.

Individual subsidized public housing programs identify a MFI tier for which their services are targeted to serve. For example, an Subsidized public housing community may reserve a specific number of units for households earning below 30 percent MFI and another for those earning below 50 percent MFI. Or, a developer seeking tax credits may be required to set aside a specific number of units for households earning below 80 percent MFI.

FPL guidelines do not match up directly to the MFI levels used to determine qualification for subsidized public housing. For households of one to three people living at the poverty level, the MFI limit is 30 percent. For households of four or more, the MFI limit is 40 percent.

In summary, the only subsidized public housing units reserved for individuals and families living below the poverty level are those which set the maximum income limit at 40 percent of the Austin-Round Rock MFI.

Unfortunately, there is an extremely limited stock of subsidized public housing units reserved for those living in poverty in Travis County. According to countywide data provided by the City of Austin Neighborhood Housing and Community Development Department, there are only 660 subsidized public housing units reserved for the 33,061 families in poverty in Travis County. And of these 660 subsidized public housing units, only 168 reside in the nine focus areas with the highest concentrations of poverty highlighted in this report.

Chronic Conditions

Patients experiencing chronic conditions—long-lasting health conditions or diseases—often require additional resources to manage their health care needs. Inadequate care for these patients often leads to overutilization of emergency departments—creating operational and financial strains on the safety-net health care system.

Understanding the geography of where this patient population resides as well as where and how they are accessing services is vital to determining strategies for improving health and reducing unnecessary hospital utilization. In the following pages this report provides demographic breakdowns of the patient population for the seven chronic conditions monitored by Central Health:

- Behavioral Health
- COPD (chronic lung disease)
- Diabetes
- Heart failure
- Hypertension
- Malignant Neoplasm
- Renal failure (kidney failure)

Continued need along I-35

The I-35 corridor—particularly north and south of downtown Austin—contains the zip codes with the highest total patients (Page 6) and patients experiencing chronic illnesses. These areas include the Rundberg and St. John’s neighborhoods to the north, and the Franklin Park and South Congress neighborhoods to the south. Based on the current need and the projected increases of families in poverty in these areas, the I-35 corridor will remain an important area to focus service delivery and improvements.

Outlying Areas

Del Valle, Colony Park and Pflugerville all show up among the areas with the highest total patients and among those with the high numbers of patients with chronic conditions. These three areas are also projected to experience high rates of total growth and of families in poverty. Ensuring access to health care is available in these areas will be among the priorities of Central Health in the coming years.

Provider Locations

Two of the locations consistently appearing among the top 10 visited sites—UMC Brackenridge and CommUnityCare Rosewood-Zaragosa—have moved operations. It will be important to monitor the utilization of current sites to determine how and where these patients are accessing services. A positive trend among the utilization data is the high number of visits at CommUnityCare’s North Central Health Center and Central Health Southeast Health & Wellness Center locations. Both of these sites were developed within the last decade to serve two of the areas with the highest need in Travis County, North Austin/Rundberg and the Montopolis/Pleasant Valley neighborhoods. Both of these locations are also equipped to provide a wide array of patient care, including pharmacy, dental, specialty care and social service assistance.

Race/Ethnicity

Hispanic/Latino residents comprise 59 percent of the population within the nine focus areas identified in this report (Page 39), but count toward 67 percent of CCC patient population. Conversely, Whites and African-Americans make up a smaller percentage of patients than are represented in the total population within the focus areas.

Age/Gender

The age 18-65 demographic makes up 64 percent of the population in the focus areas, but represents 89 percent of Central Health’s patient population. The comparatively low numbers of adolescent and age 65-plus patients may be a result of the provider options available to low-income Medicaid/CHIP and Medicare recipients.

The gender diversity skews heavily female among Central Health’s patient population (55 percent), despite 51 percent of the residents within the focus areas being male.
